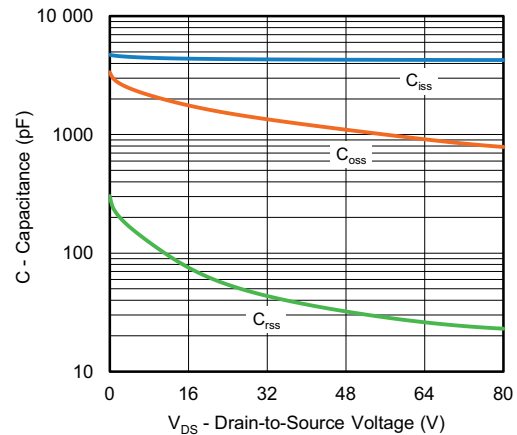

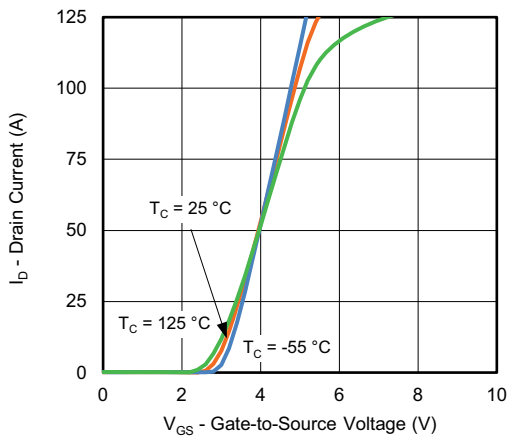
Transconductance



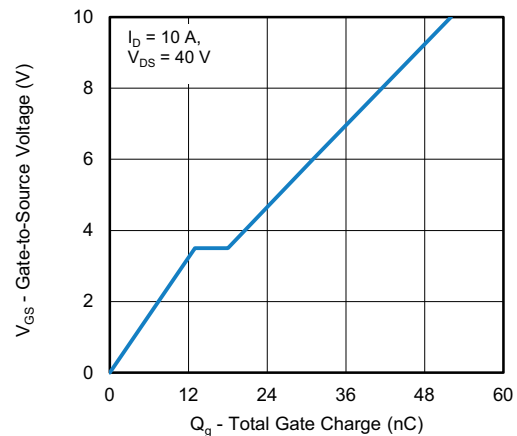
On-Resistance vs. Drain Current



Capacitance

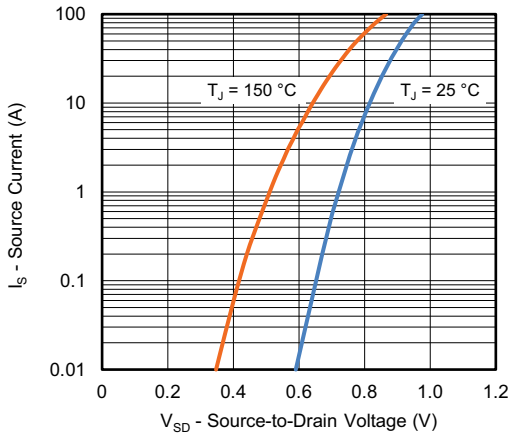

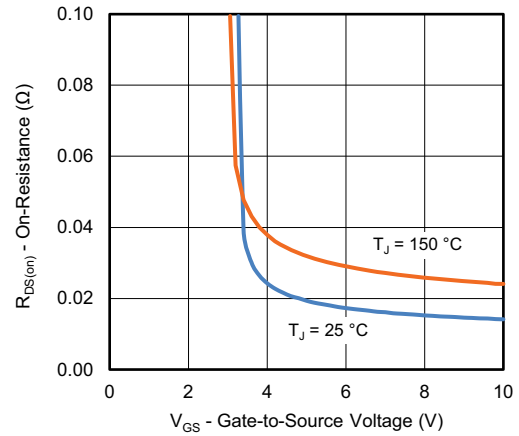

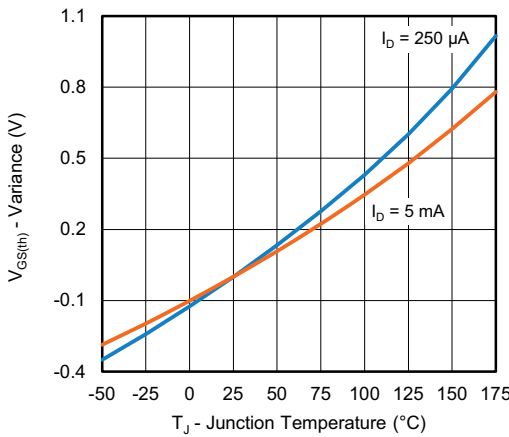

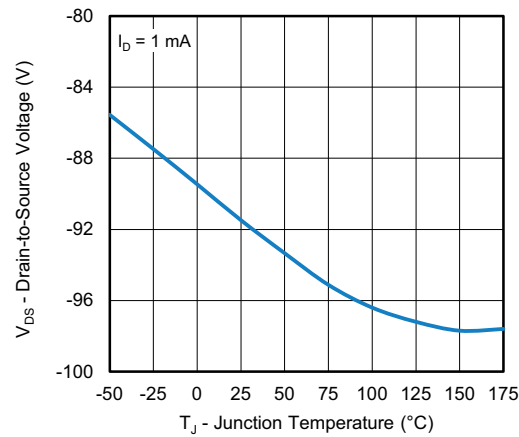
Source Drain Diode Forward Voltage



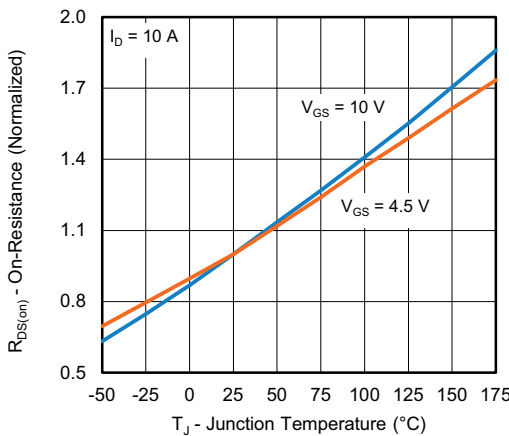
On-Resistance vs. Gate-to-Source Voltage



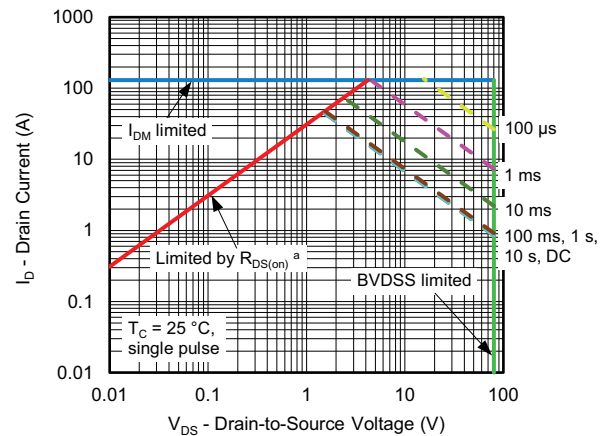
Threshold Voltage

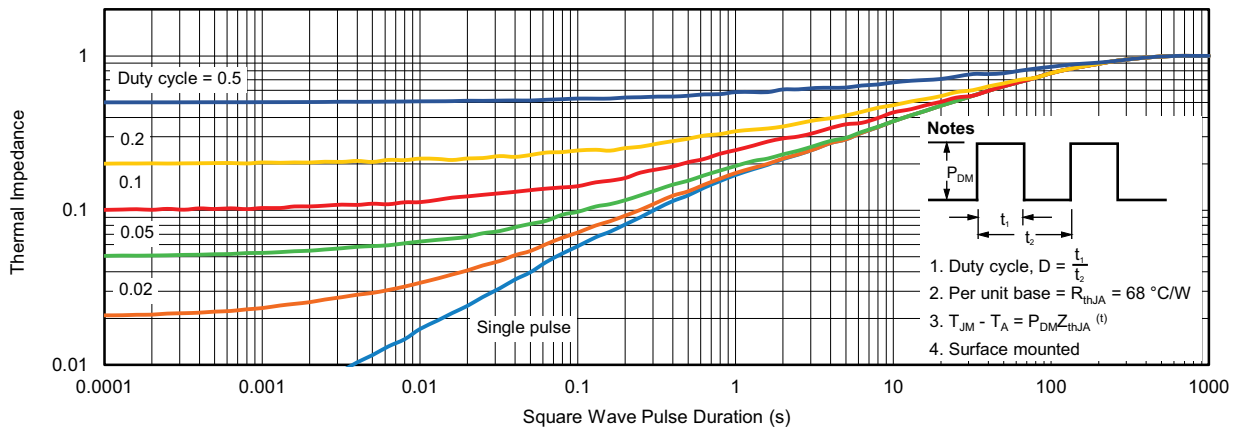

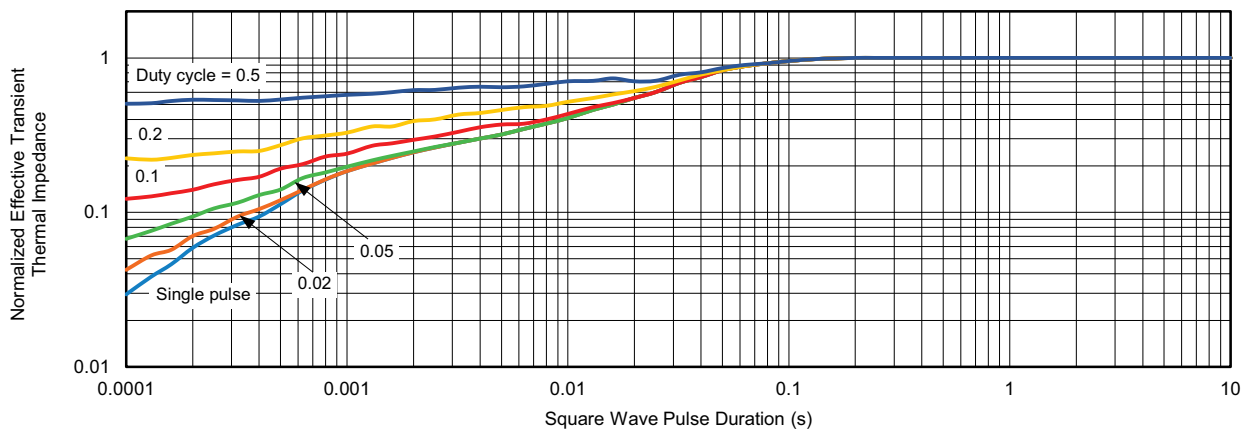

Normalized Thermal Transient Impedance, Junction-to-Case

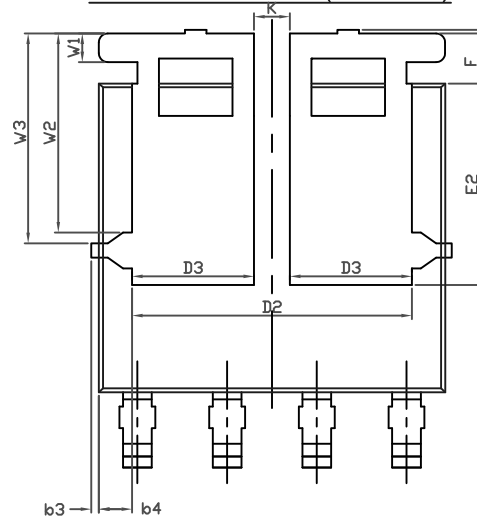
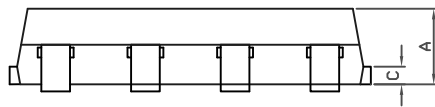
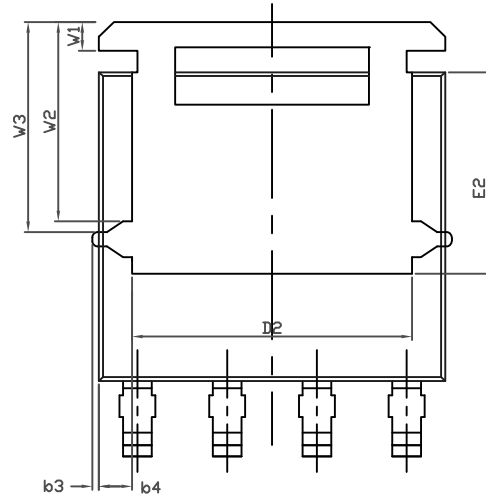
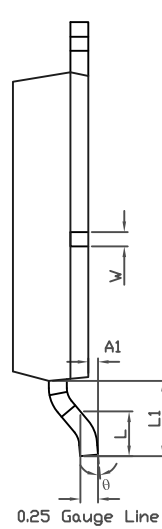
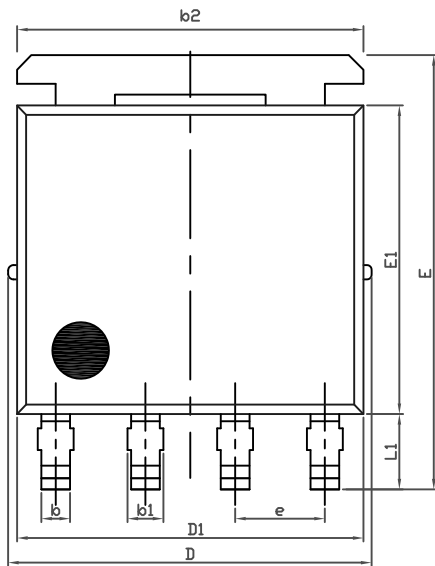
